8 Items for discussion and/or reports

a Director Report: ICT continues to meet. We are pleased with the overall cases going down. We have been responding to the new guidelines. We are planning on outdoor graduation for Saturday, June 5, 2021. We have been able to hold true to many traditions like personal projects. The safe learning plan is in place until the last day of school. The District Advisory Committee met on Wednesday of this week. We discussed specials and there was a strong message from the committee that Spanish is an important part of the school. After discussion with the teachers a decision has been made to have a Spanish special again next year.

b Education Program Update: Math has been discussed at the teachers PD. They are looking at a new math curriculum for possible use next year. Illustrative Math is the curriculum. After extensive review by faculty, it was determined that this curriculum best supports the transition back to in-person learning model and matches our inquiry-centered approach to math while providing a scope and sequence for foundational skills instruction. Teachers have been reflecting on multiple areas and feel good to be able to get back to the discussion. They have also been talking about onboarding of new teachers and what work needs to go into developing a new teacher.

- c Finance Committee: Our fund balance is still projected to be in good standing. We have received about \$91,000 in COVID funding. We are most likely getting another \$63,000 next school year. Fund 4 has always had a balance that we have been working down. This year is no exception. We have applied for forgiveness of our PPP loan. We are expecting to have it forgiven. If it is not forgiven before the end of the year we will need to carry it forward as a liability. When it is forgiven it will go right into our fund balance.
