a Director Report: Don noted that the personal research project fair happened for the k/1 & 3/3 teams. Upon this inquiry, the subgroup feels confident that the school handled each situation in an appropriate and responsive manner that was in keeping with school policies and mission. The survey results were overall favorable.
